- 2) Certified copy of Certificate of your “Diplom” examination, Master’s examination, doctoral examination, state examination according to Art. 4 Sect. 3
- 3) Eight copies (old regulations) OR seven copies (new regulations) of your doctoral thesis according to Art. 11 Sect. 2,
 - with an abstract in German language as a prefix according to Art. 11 Sect. 2 Sent. 3;
 - if applicable, the respective number of special printouts of publications according to Art. 11 Sect. 1 Sent. 3
 - Copy of the abstract in German language printed on a separate page and to be sent by e-mail as a PDF file to the Dean’s Office (Dekanat17@lmu.de).
 - Digital Version of the dissertation as a PDF or link to be sent to the Dean’s office as well
- 4) In case of a cumulative doctoral thesis, please bring with you: The previously obtained Dean’s written approval of your application for a cumulative doctoral thesis according to Art. 11 Sect. 1 Sent. 4 and 5.
- 5) The applicant’s declaration according to Art. 6 Sect. 1 Sent. 2 no. 5 as to whether, and, if applicable, by whom their doctoral thesis has been supervised; if applicable, the resolution of the Department Council [Fachbereichsrat] on the acceptance of the doctoral thesis prepared without supervision according to Art. 12 Sect. 4 Sent. 3 – see Application for Admission to the Doctoral Examination, p. 3.
- 6) Sworn declaration according to Art. 6 Sect. 1 Sent. 2 No. 6 – see Application for Admission to the Doctoral Examination, p. 4.

- 9) Proof of enrolment attesting that the applicant has been enrolled during at least two semesters (or substitute regulation) according to Art. 4 Sect. 4. (New regulations: not necessary)
- 10) The applicant’s official Certificate of good conduct according to Art. 6 Sect. 1 Sent. 2 no. 9, which must not be older than two weeks in case the applicant hasn’t been enrolled for more than three months ago and is not employed in the public sector. In case the applicant is employed in the public sector at the time he/she submits his/her doctoral thesis, a copy of the work contract will suffice.
