- with an abstract as a prefix according to Art. 10 Sect. 2 Sent. 2;
- if applicable, the respective number of special printouts of publications according to Art. 11 Sect. 1 Sent. 2
- 4) To be sent in advance to the dean's office as a PDF or link (Dekanat17@lmu.de)
- Copy of the abstract in German language printed on a separate page
- **Digital version** of the dissertation
- 5) In case of a cumulative doctoral thesis, please bring with you: The previously obtained Dean's written approval of your application for a cumulative doctoral thesis according to Art. 11 Sect. 1 Sent. 4 and 5.
- 6) **Sworn declaration** according to Art. 6 Sect. 1 Sent. 2 No. 6 see Application for Admission to the Doctoral Examination, p. 4.
- 7) **Declaration on previously undertaken attempts** to acquire a doctoral degree according to Art. 6 Sect. 1 Sent. 2 No. 7 see Application for Admission to the Doctoral Examination, p. 4.
- 8) **Declaration on submission of the doctoral thesis** to other examination committees according to Art. 6 Sect. 1 Sent. 2 No. 8 see Application for Admission to the Doctoral Examination, p. 3.
- 9) The applicant's **official Certificate of good conduct** (behördliches Führungszeugnis) that must be no older than three months. Applicants with a nationality other than the German additionally need a corresponding confirmation from the respective foreign government agency:
 - For European applicants the latter will automatically be included upon applying for the German version at the KVR in Munich.
 - ➤ Non-European applicants have to apply at the KVR as well as the consulate of their home country.
