Development Economics: Firms in Developing Countries Anik Ashraf, Ph.D. LS (Seminar) Wintersemester/winter semester 2025-26

The aim of this seminar will be to discuss the recent evidence on the challenges faced by firms in developing countries and what can be done to overcome them. We will be discussing mainly empirical papers. At the end of the course you will have seen and discussed some of the recent empirical evidence on the characteristics of firms in developing countries, and factors that constrain their productivity and growth. We will explore issues related to human capital development, public and private institutions, access to finance, technology, and trade.

We will hold a preliminary meeting to discuss the seminar and syllabus, following which you will state a preference over what topic you want to work on. You will need to state your preferences within the first week of our preliminary meeting. Once (and only once) you state your preferences your participation in the seminar will be binding. You will then be assigned an academic paper based on your preferred topic, and subsequently you will have four weeks to write a term paper on that paper. There will be two supervisory meetings while you work on your term paper – one within the first two weeks, and one within the second two weeks. You can also contact over emails if you have short questions. After you submit your term paper, you will be required to present your paper to the whole group.
